Declaration of results of voting through remote e-voting and by physical ballots at the Extra-ordinary General Meeting ('EGM') of The Indian Performing Right Society Limited held on 3rd August, 2018

In terms of Section 108 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, **The Indian Performing Right Society Limited** ('the Company') provided remote e-voting facility and voting through Ballot papers to the Members to cast their vote on resolutions proposed vide Notice dated 22nd June, 2018 of Extra-Ordinary General Meeting ('EGM').
