Declaration of results of voting through remote e-voting prior to and by ballots at 52nd Annual

General Meeting of The Indian Performing Right Society Limited held on 15th September, 2022

In terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, **The Indian Performing Right Society Limited** ('the Company') provided remote e-voting prior to and physical voting through ballots at the 52nd Annual General Meeting held on 15th September, 2022 (52nd AGM) in respect of the resolutions contained in the Notice dated 30th June, 2022 of 52nd AGM (Notice) and Addendum to Notice dated 3rd September, 2022, placed for the approval of Members of the Company.
