Sub: Scrutinizer's Report on the remote e-voting and physical voting through ballots at 52nd
Annual General Meeting (52nd AGM) of the members of The Indian Performing Right
Society Limited held on 15th September, 2022.

Dear Sir,

The Indian Performing Right Society Limited ("the Company") at their Board Meeting held on 30th June, 2022 appointed the undersigned as the Scrutinizer to ensure that the process of remote e-voting and physical voting through ballots as prescribed under Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time, at the 52nd Annual General Meeting held on 15th September, 2022 (52nd AGM) in respect of the resolutions contained in the Notice dated 30th June, 2022 of 52nd AGM and Addendum to Notice dated 03rd September, 2022, placed for the approval of Members of the Company, be carried out in a fair and transparent manner.

The management of the Company is responsible to ensure the compliance with the requirements of the Act and rules made thereunder, relating to remote e-voting and physical voting by ballots on the resolutions as contained in the Notice and Addendum to Notice. My responsibility as a Scrutinizer is to scrutinize and ensure that the voting done through remote e-voting and physical voting by ballots is done in a fair and transparent manner and to make a Consolidated Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the reports generated from the remote e-voting system of Central Depository Services (India) Limited ("CDSL") the agency engaged by the Company to provide remote e-voting facility. Further, the Company distributed ballots to the members present at the 52nd Annual General Meeting to enable them to vote.

Pursuant to Section 101 of the Act, Notice of 52nd AGM and Addendum to Notice of 52nd AGM along with Explanatory Statement under Section 102 of the Act were sent to the Members by permitted means, for seeking the approval of the Members on following resolutions:



- Resolution No. 1 as an Ordinary Resolution for adoption of Audited Balance Sheet as on 31st March 2022, Income and Expenditure Account and Cash Flow Statement for the year ended on that date and the Reports of Directors and Auditors thereon and the Annual Transparency Report for F.Y. 2021-22, in respect of the Company's administration of the Performing/Mechanical and other Rights vested in it by its members and the Confederate Societies.
- 2. **Resolution No. 2** as a Special Resolution for re-appointment of Mr. Upadrashta Vidya Sagar (DIN: 08304251), Author-Composer Director, Region South, who retired by rotation and being eligible, had offered himself for re-appointment.
- 3. **Resolution No. 3** as a Special Resolution for re-appointment of Mr. Sumit Chatterjee (DIN: 02269713), Publisher Owner Director representing Sony Music Entertainment India Private Limited, Region West, who retired by rotation and being eligible, had offered himself for re-appointment.
- 4. Resolution No. 4 as a Special Resolution for re-appointment of Mr. Aditya Gupta (DIN: 02815692), Publisher Owner Director representing Aditya Music (India) Pvt. Ltd., Region South, who retired by rotation and being eligible, had offered himself for reappointment.
- 5. **Resolution No. 5** as a Special Resolution for re-appointment of Mr. Sahithi Cherukupalli (DIN:07769259), Author Director, Region South, who retired by rotation and being eligible, had offered himself for re-appointment.
- 6. **Resolution No. 6** as a Special Resolution for appointment of Mr. Tapas Relia (DIN: 09562466) as Author-Composer Director, Region North, who shall be liable to retire by rotation.
- 7. Resolution No. 7 as a Special Resolution for approval of the "Tariff Scheme" framed and presented by the Governing Council pursuant to the Copyright Act, 1957 and Copyright Rules, 2013 for the financial year 2022-23 and onwards and to authorize the Board of Directors to revise/alter/modify Scheme based on the collections made, from time to time and to take all such actions as may be required to give effect to this resolution and matters related thereto.
- 8. **Resolution No. 8** as a Special Resolution for approval of Distribution Policy/Rules and Methods pursuant to the Copyright Act, 1957 and Copyright Rules, 2013.
- 9. **Resolution No. 9** as an Ordinary Resolution for declaration pursuant to Rule 47(3) of the Copyright Rules, 2013 in the matter of renewal of Registration of the Company as Copyright Society under the Copyright Act, 1957.

10. **Resolution No. 10** as a Special Resolution for appointment of Mr. Syed Ahmed (DIN: 08298783), as an Author-Composer Director, Region - East, of the Company, who shall be liable to retire by rotation.

The Company provided remote e-voting facility offered by CDSL to cast votes on aforesaid resolutions by the members of the Company.

Remote e-voting facility was made available to members of the Company to exercise their voting rights from 9.00 a.m. of Monday, 12th September, 2022 upto 5.00 p.m. of Wednesday, 14th September, 2022. Accordingly, e-votes cast up to 5.00 p.m. of Wednesday, 14th September, 2022 have been considered for my scrutiny.

After the conclusion of the 52nd Annual General Meeting, physical voting conducted through ballots at the meeting was unlocked in the presence of witnesses being the members of the Company, namely Mr. Utpal Jivrajani and Mr. Mayur Chouhan for voting by Author- Composer Members and Mr. Vishal Kataria and Mr. Sanjayraj Gaurinandan for voting by Publisher Owner Members. Thereafter the voting through remote e-voting was unblocked in the presence of two witnesses not in employment of the Company, namely Ms. Rashi Shah and Ms. Twinkle Wadhwa. In case of members who voted through remote e-voting prior to as well as by ballots at the 52nd Annual General Meeting, the ballots of such members were treated as invalid.

In accordance with Article 24 of the Articles of Association of the Company, Author-Composer Members were permitted to vote on resolutions for appointment of Author-Composer Directors and Publisher-Owner Members were permitted to vote on resolutions for appointment of Publisher-Owner Directors. In case of members who voted otherwise, their respective votes were deemed to be invalid.

A summary of the votes casted by members through remote e-voting prior to and by ballots at the 52nd Annual General Meeting with their pattern of voting is as per Annexure annexed to this Report.

The results of the voting by members through remote e-voting prior to and by physical ballots at the 52nd Annual General Meeting in respect of the above mentioned resolutions may accordingly be declared by the Chairman of the Company.
